APPLICATIONS:

a. <u>2012-05</u> – Arthur Peterson Block 31, Lot 1 – 193 Quinton-Alloway Road Minor Subdivision with Bulk Variance Represented by Frank J. Hoerst, III, Esq.

Appearing for the Applicant – Arthur Peterson was Frank J. Hoerst, III, Esq., Kenneth Dale Peterson (Dale – Arthur Peterson's son, and Power of Attorney) and Kenneth Peterson (Kenny is the grandson of Arthur Peterson and son of Dale Peterson). Gary Salber, Esq. swore in everyone.

Mr. Hoerst explained the application for the Peterson's to the Board members and public. The "application is for a minor subdivision to create a freestanding 3-acre lot for future development of a residential dwelling that would be excluded from the farmland restriction" and "establish a separate lot for a preserved farmland which would maintain the property in its existing condition in accordance with the terms and conditions of the Farmland Preservation Agreement."

Kenneth Peterson will farm the land as his family has done for many years. There will be a Deed of Easement which will restrict development on the 21.64 acres to be known as Block 31, Lot 1 located in Quinton Township. The residential site of 3 acres will be known as Block 31, Lot 1.01 will be for the future residential dwelling for Kenneth Peterson.

The sewer connection will be a condition of approval based on the building inspector's findings. A dry line will be put in now so connection at a later date will be all set up.

Lawrence M. DiVietro, P.E. discussed the results of his review of the materials submitted for the Arthur Peterson application as outlined in his review letter dated December 5th, 2012.

James Kates stated that Mr. DiVietro prepared a good report.

Solicitor Salber stated that the report was very thorough.
