- 4. All advance notices referred to in this Resolution of the aforesaid meetings of the Quinton Township Planning Board shall, to the extent known, include:
 - a. The Agenda; and
 - b. Those matters upon which formal action may be taken.

5. Upon the affirmative vote of three-fourths of the Board members present, a meeting may be held without compliance with the notice requirements of this Resolution, if such meeting is required to deal with matters of such urgency and importance that delay for purpose of providing adequate notice would be likely to result in substantial harm to the public interest.
