Thom as 2023 Planning Board Secretary or, if Melissa N. Thom is not so appointed, expiring at 6:59 p.m. prevailing time on the date of the Board's 2024 reorganization meeting; and

WHEREAS, the Board desires to appoint Melissa N. Thom to serve as Assistant 2023 Planning Board Secretary with a term of appointment commencing retroactively as of February 1, 2023, and continuing until the Board's appointment of Melissa N. Thom as 2023 Planning Board Secretary or, if Melissa N. Thom is not so appointed, expiring at 6:59 p.m. prevailing time on the date of the Board's 2024 reorganization meeting; and

WHEREAS, the Quinton Township Chief Financial Officer has confirmed that the aforesaid appointees and their respective employment and contract terms have been approved by the Quinton Township Committee, and that the expenditures for same will not exceed amounts appropriated by the Quinton Township Committee;

Thom is hereby appointed as Assistant 2023 Planning Board Secretary, with the term of her appointment commencing retroactively as of February 1, 2023, and continuing until the Board's appointment of Melissa N. Thom as 2023 Planning Board Secretary or, if Melissa N. Thom is not so appointed, expiring at 6:59 p.m. prevailing time on the date of the Board's 2024 reorganization meeting.
