#### **RESOLUTION NO. 2021-84**

RESOLUTION AUTHORIZING THE CANCELLATION OF A PORTION OF THE THIRD AND FOURTH QUARTER 2021 TAXES FOR A TOTAL DISABLED VETERAN(N.J.S.A. 54:4-3.30, et seq.; N.J.A.C. 18:28-1.1 et seq.) Block 62, Lot 8 and 8 QFarm (Hitchner, Howard S.)

WHEREAS, THE TAX ASSESSOR OF QUINTON TOWNHIP, Salem County, has certified by Memorandum dated October 8, 2021 (a copy of which is attached to this resolution), that the above-referenced total disabled veteran taxpayer has been approved for tax exempt status as of July 7, 2021, the date the total disabled veteran's application; therefore, a portion of the third, and fourth quarter 2021 taxes for the subject property should be cancelled and/or refunded; and

WHEREAS, the subject property consists of approximately 43.50 acres of land (according to deeds of record), part of which is improved with a single-family dwelling house, and part of which is preserved, farm qualified land; and

WHEREAS, the Tax Assessor has approved the total disabled veteran taxpayer's exemption for the single-family dwelling house at the subject property, and for a 2.00-acre portion of the subject property (curtilage area) within which the dwelling house is located; and

WHEREAS, the remaining 41.50+/- preserved, farm qualified acres (Block 62, Lot 8 QFarm) will continue to be assessed and taxed, therefore such remaining acreage does not qualify for tax cancellation or refund; and

WHEREAS, the amount of \$1,830.27 shall be refunded to the property owner,

Hitchner, Howard S., 14 Telegraph Road, Bridgeton, New Jersey 08302; and

WHEREAS, THE TREASURER OF QUINTON TOWNSHIP is authorized to make said refund from the Current Account; and

WHEREAS, THE TAX COLLECTOR OF QUINTON TOWNSHIP has certified to the Township Mayor and Committee that the above-referenced 2.00-acre portion of the 43.50-acre subject property has been approved for a total disabled veteran exempt status as of July 7, 2021 as described above; therefore, a portion of the third, and fourth quarter 2021 taxes should be cancelled and /or refunded accordingly;

NOW, THEREFORE, BE IT RESOLVED, by the Quinton Township Committee, that the appropriate officials of Quinton Township, County of Salem, State of New Jersey, shall cancel and/or refund a portion of the third, and fourth quarter 2021 real estate taxes as noted above, and the books of said Tax Collector be adjusted to reflect the cancellation and/or refund as noted above.
