RESOLUTION NO. 2022-83

RESOLUTION BY THE TOWNSHIP COMMITTEE, OF THE TOWNSHIP OF QUINTON, IN THE COUNTY OF SALEM, STATE OF NEW JERSEY AUTHORIZING THE DATE OF AUGUST 24TH 2022 FOR THE RECEIPT OF THIRD QUARTER 2022 PROPERTY TAX; AFTER WHICH THIRD QUARTER 2022 PROPERTY TAXES ARE DELINQUENT AND INTEREST SHALL BE CHARGED STARTING FROM AUGUST 1, 2022

WHEREAS, the Tax Collector of the Township of Quinton has sent out the 2022/2023 property tax bills on Friday, July 29, 2022 and;

WHEREAS, New Jersey State law requires that when third quarter tax bills are issued after July 16th, a 25 (twenty-five) day interest free period is required before such taxes are subject to interest penalties, and;

NOW THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Quinton, County of Salem, State of New Jersey that it hereby sets August 24th, 2022, as the end of the interest free period for the third quarter 2022

BE IT FURTHER RESOLVED, that after August 24, 2022 any property taxes received shall be subject to interest retroactive back to the due date of August 1, 2022.

BE IT FURTHER RESOLVED, that the Township Clerk forward a copy of this resolution to the Tax Collector for her records.

(6) The third installment of taxes shall not be subject to interest until the later of August 1, the additional interest-free period authorized pursuant to R.S.54:4-67, or the twenty-fifth calendar day after the date that the tax bill or estimated tax bill for the third installment was mailed or otherwise delivered.

Any payment received after the later of August 1, the additional interest free period authorized pursuant to R.S.54:4-67, or the twenty-fifth calendar day after the date that the tax bill or estimated tax bill for the third installment was mailed or otherwise delivered may be charged interest back to August 1. The estimated tax bill shall contain a notice specifying the date on which interest may begin to accrue.
