ORDINANCE TO BE ADOPTED

ORDINANCE NO. 2024-09 MUNICIPAL STORMWATER CONTROL ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF QUINTON, COUNTY OF SALEM, STATE OF NEW JERSEY, AMENDING CHAPTER 216 "STORMWATER MANAGEMENT" OF THE CODE BOOK OF THE TOWNSHIP OF QUINTON TO INCLUDE REQUIREMENTS AND CONTROLS APPLICABLE TO MAJOR DEVELOPMENTS

Flood control, groundwater recharge, and pollutant reduction shall be achieved through the use of stormwater management measures, including green infrastructure Best Management Practices (GI BMPs) and nonstructural stormwater management strategies. GI BMPs and low impact development (LID) should be utilized to meet the goal of maintaining natural hydrology to reduce stormwater runoff volume, reduce erosion, encourage infiltration and groundwater recharge, and reduce pollution. GI BMPs and LID should be developed based upon physical site conditions and the origin, nature and the anticipated quantity, or amount, of potential pollutants. Multiple stormwater management BMPs may be necessary to achieve the established performance standards for water quality, quantity, and groundwater recharge.

Solicitor Vigilante explained this Ordinance is one of several the DEP is requiring in order for towns to maintain Tier A permit. This ordinance has requirements for Major Development. Beth Fox asked if current applications would have to comply with this ordinance. Solicitor Vigilante said applications that are existing or pending fall under the old standards.

Application is pending and will be heard on July 24, 2024 at 7:30pm. It is an open building. Solicitor Vigilante did say there is a discrepancy on the amount of property in use.

Mr. Shultz – Gill drive is still gated and now overgrown. Solicitor Vigilante sent the pictures to the court an will follow up.

Larry Winkels – wants to purchase a ¾ of an acre near him. He also brought up purchasing it through the Jones Act. Solicitor Vigilante said she would research the Jones act and then explained how the township can acquire and sell land. She also explained that the state has changed some of the rules involving foreclosures and we will look into the Jones Act.

Beth Fox asked what the Blue light permit is? Mayor Sperry said it is a light for a firemen's car to use when responding to a fire.
