PUBLIC SESSION

- **T. Boker** inquired about the status of his application submitted for the alternate No. 3 vacancy on the planning board. Mayor Sperry responded, after consulting with the planning board's solicitor, Bill Horner, that it was not recommended to proceed with Mr. Bokers' application at this time. This decision is based on concerns of conflict arising from previous public statements made by Mr. Boker stating his opinion on the warehouse, which currently has an outstanding appeal pending.
- **L. Winkles** asked for clarification on Ordinance 2025-04. Deputy Mayor Owens explained that this is updated yearly as the township works to pay down our sewer debt. The fee is adjusted annually by calculating the physical costs of time, materials, the increase in debt, and capital expenditures, divided by the number of service units from the previous year. He reiterated that this fee applies only to residents who would be new connections to the sewer. Mayor Sperry also noted that we are not permitted any new hookups, as we are already over our flow limit.
- **P. Matisse** inquired about his freedom of speech and how this could be a conflict, as he also applied to be considered for the planning board alternate no. 3 vacancy. The solicitor replied that if a person wishes to exercise their First Amendment right, it may be considered when applying for appointment. Mayor Sperry added that they should also be familiar with the township land ordinances before voicing their opinion publicly. Mr. Matisse then inquired when he could reapply for consideration as a planning board alternate. Mayor Sperry replied that if there is a change in the appointed Mayor, a vacancy on the planning board, and being that the current appeal with the warehouse has settled, he may reapply for consideration.
- **T. Boker** inquired about the appeal process, the solicitor replied: that there must be five unconflicted planning board members; if the board is unable to reach a decision, then the alternates would step in. If the alternates

cannot decide, the planning board would not have a forum to make decisions, therefore, the appeal would then go before a judge. This process is typically on paper and rarely goes to a hearing/trial.

E. Schultz inquired about the status of Freedom Farm. The solicitor replied that, to her understanding, the State Board of Agriculture did not extend their permit for shooting or hunting. Freedom Farm was approved to raise quail or other birds there; however, it needed to develop a waste disposal and storage plan for the NJDEP. Freedom Farm will not be coming to the township for any permits; therefore, it was suggested that Ms. Schultz consult with the State Board of Agriculture and NJDEP for any future updates on Freedom Farm's status. Ms. Schultz also inquired if there were any updates on when Acton Station Road will be repaved. Mayor Sperry replied that Acton Station is a county road, and to her knowledge, the county was applying for grant funding.
