# **Chairperson of Administration and Environmental**

Mayor Sperry reported that the Municipality will incur an additional monthly cost of \$60,659.17 for Quinton Township Elementary School from July 2025 through June 2026. She noted that the Township's monthly payment to the school will increase from \$250,082.00 in the prior year to \$310,741.00.

The Clerk's Office reported two new roof leaks at the Municipal Building following the July 31, 2025, storm; Maintenance (Allison O'Boyle) was notified.

#### **PUBLIC SESSION**

## P. Rivel: Inquired about the school tax increase.

- M. Sperry: The Quinton Township Elementary School board approved the tax increase to cover a deficit caused by the removal of state funding.
- J. Hannagan: Noted that the Township Committee was not involved in voting for the tax increase.
- P. Rivel: What funding was taken away?
- R. Owens: Referenced Governor Murphy's School Funding Reform Act (SFRA).

Solicitor: Some state funding has been withdrawn; however, the school still has a budget to fulfill, so the school board voted to increase residents' taxes to cover the shortfall.

- D. Perry: Will this increase appear on the tax bill under the 'school' line?
- M. Sperry: Yes.

## P. Remster: Inquired about Resolution 2025-90.

M. Sperry: Explained that, following discussions with the Planning Board Solicitor, it was determined that state law permits up to four alternate members; however, Quinton Township's ordinance allowed only two. As a result, the original resolution was rescinded.

Solicitor: Reported that the ordinance has since been amended to allow up to four alternates per state law.

M. Sperry: Referenced Resolution No. 2025-92 allowing the appointment of alternate members no. 3 and no.4.

#### T. Boker: Inquired about any updates regarding the Freedom Farms pending lawsuit.

Solicitor: Reported there were no updates at this time, noting that while the property owner retains the right to farm, shooting is not permitted. Concerns were raised regarding the buildings constructed on the property. The Township's Construction and Zoning Officials will advise the Solicitor if any violations are identified.

## T. Boker: Inquired if there are any updates regarding the Warehouse pending lawsuit – Planning Board issue.

Solicitor: Normally, any pending litigation is discussed during a closed session with the members of the planning board.
