WHEREAS, American Water has presented Quinton with an addendum to the Shared Services Agreement which is attached hereto as Exhibit A; and

WHEREAS, Alloway agrees and consents to the attached Addendum to the Shared Services Agreement and agrees that the attached Addendum shall modify the existing Shared Services Agreement between Alloway and Quinton for payment of the American Water fees and that Alloway shall share equally in all costs incurred by Quinton pursuant to the Agreement with American Water.

NOW THEREFORE, BE IT HEREBY RESOLVED, by the Township Committee of the Township of Quinton that the attached Addendum to the Shared Services Agreement is approved and shall modify the existing Shared Services Agreement between Alloway and Quinton for payment of American Water fees.
